

# BURRENDALE COUNTRY CLUB

## TERMS AND CONDITIONS

### **The Club**

Members of the Burrendale Country Club are bound as a regulation of their membership to comply with the regulations set out below. These have been drawn up with a view to ensure that the Leisure Clubs Facilities are properly and safely used and that all members are able to take advantage of them without interfering with the enjoyment of others.

The club is a propriety club, the proprietors and sole managers of which (subject to these rules) is the Burrendale Hotel Ltd; hereafter referred to as The Company. The Company has sole responsibility for the control and operation of the Club and any additions, deletions or replacements hereto shall be at the Companies sole discretion. For Health & Safety reasons there will be a limited number of members. The number will be at the discretion of the management.

### **Membership**

To become a member an official application form should be completed and submitted to the Country Club Manager with the relevant entry fee and appropriate subscription. The management acting on behalf of the company has absolute discretion to reject any application or renewal of membership without giving any reason for doing so. All successful applicants will be issued with membership keyrings which must be used to gain entry.

### **Residents**

All hotel residents are automatically temporary members of the Club and must abide by these rules. Residents must sign in at Club reception.

### **Subscriptions**

Entry fees and subscriptions shall be amounts determined by the management and may change from time to time.

Administration charges may be levied on amendments to memberships. Memberships are non-transferable and non-refundable. Unpaid fees will result in cancellation.

If you are a member paying by direct debit it will be listed on your bank details as payment on the 15<sup>th</sup> of every month.

Unfortunately, we are unable to change the date of direct debits. We would however like to point out that the payment may be taken from your account several days after this. Please Note: Direct Debit members are on a rolling contract.

If you wish to cancel your direct debit please notify the Company and the Bank in writing. This needs to be with us on the first week of the month, later than this can result in another month's payment, this will be non-refundable. Direct Debit agreements must be set with your bank in advance of collection. In some cases, we may require the first month's payment on joining. If payment is not received from your bank we will call for two payments the following month. Should the second payment fail then your membership will be automatically cancelled.

### **Children**

Children under 16 years will be accompanied by an appropriate adult at all times. For safety reasons children will not be permitted in the gym, steam room, sauna or jacuzzi. Children must vacate the Country Club by 6.30pm.

### **Guests**

Guests of a member will be required to pay the appropriate fee. Members are responsible for ensuring that each guest complies with the rules and regulations of the Club. A member shall not leave the Club without their guests. Only members over 16 years may introduce guests to the club.

### **Dress Code**

Members and guests are required to dress appropriately for the activity they are undertaking. Training shoes must be worn in the gym and at classes. No Club affiliated sportswear will be permitted in the club. In the interest of Health & Hygiene we strongly recommend that Flipflops are worn in the pool area.

### **Particular Facilities**

The facilities listed below must be vacated 15 minutes prior to closing to allow time for showering and dressing and they are only to be used during the official opening hours of the club.

### **Swimming Pool**

In the interest of hygiene, users of the swimming pool are requested to shower before swimming. Inflatable airbeds will not be permitted in the pool area. No running, jumping in or diving is allowed in the pool area. Children under the age of 16 years must be accompanied by a responsible adult and children under 8 must be accompanied in the water at all times.

**The pool is not attended by a staff member or life guard.**

### **Steam Room/Sauna**

No children under the age of 16 years are allowed in this area. Shaving is not permitted in this area. Persons suffering from heart or circulatory problems, high blood pressure or kidney disease refrain from using this facility. Pregnant women are not permitted to use this facility.

### **Jacuzzi**

In the interest of hygiene, you are requested to shower before entering the Jacuzzi. Correct attire must be worn. Members must not use this facility under the influence of alcohol, anticoagulants, antihistamines, vasoconstrictors, narcotics or tranquillisers. Those suffering with diabetes, heart disease or high/low blood pressure should check with their GP prior to using this facility. Pregnant women are advised not to use this facility. Children under 16 years are not permitted to use the Jacuzzi for health reasons. It is advisable not to use the Jacuzzi for longer than 15 minutes.

### **Gymnasium**

The facility will only be available to those over the age of 16 years. For safety reasons, this area must be kept dry. Suitable clothing and footwear should be worn at all times. Outdoor shoes and bare feet are not permitted. Please consider other members when using the equipment. A physical Activity Readiness Questionnaire must be completed before using gymnasium. You may request a review of fitness programme every 4-6 weeks. If unsure how to use the equipment please ask a member of staff who will be more than happy to help.

### **Liability**

Members and guests use the pool and other facilities of the Club entirely at their own risk. Each member and guest is responsible for ensuring that he/she is in good physical condition and that he/she knows of no medical reason why he/she is not capable of engaging in active or passive exercise, or why such exercise might be detrimental to his/her health, safety, comfort or physical condition.

Members and guests should not use the club whilst suffering from any infections or contagious illness, disease or other ailment, or whilst suffering from open cuts, abrasions, open sores or minor infections where there is a risk that such may be detrimental to the health and safety of other users.

Supervision of each facility will not be possible at all times. All persons using or entering the club do so at their own risk. Responsibility will not be accepted by the company or their employees for any personal injury or loss of damage to property. Personal lockers are available for members and guests. However, it is advised not to leave valuables in the club.

### **Club Admission**

Members must always swipe in using their bar-coded keyring. The management will be entitled at any time, and for a period not to exceed 14 days in any one subscription year, to withdraw use of all or part of the facilities of the Club for the purposes of undertaking essential maintenance works. Compensation will not be given under these circumstances. Opening hours will be displayed on the notice board and may vary day to day or season to season.

### **Conduct of Members**

The management may suspend the membership of any member whose conduct, either to the club premises or elsewhere, is considered to be detrimental to the best interest of the Club or its reputation. Any person who has had their membership terminated will be excluded from the club and shall have no claim against it. If a member wishes to terminate their membership no refund will be given. Smoking or the drinking of alcoholic beverages is not permitted anywhere in the club.

### **Compliance with Rules**

By their subscription and joining the Club, members agree and accept to be bound by the rules of the club. Notice of any change of rules shall be given to members by exhibition on the Club notice board.

### **Complaints and Disputes**

Any complaints concerning the club should be addressed to the management of the club whose decision will be final and binding.

### **Variations**

The management reserve the right to add or amend these regulations, as it sees fit. Amendments will be placed on the Club Notice board.
